#### Location

Preston is the administrative centre for Lancashire and is the dominant retail centre for the County. CACI's in town retail rankings for the North West put Preston 4th (behind Manchester, Liverpool and Chester). Preston has a resident population of 140,202 (source: 2011 Census) with a catchment of 823,000 (source: Experian - 2016 estimate). The University of Central Lancashire (UCLAN) is based in Preston and is the 8th largest university in the UK with a student population of over 30,000.

St George's Shopping Centre is located at the heart of the city centre with entrances from the city's two main shopping streets (Fishergate and Friargate) and benefits from a 410 space multi-storey car park. Main tenants in the scheme include **H&M** (recently upsized), **New Look**, **M&S**, **River Island**, **Tiger** and **Foot Asylum** amongst others. Recent lettings have been completed to **Thomas Sabo**, **Yours** and **Hawkins Bazaar**.

The subject premises are located adjacent to The Entertainer and in close proximity to **HMV**, **H&M** amongst others on Fishergate Walk.

#### Accommodation

The premises are arranged over ground and first floors only providing the following approximate net internal floor areas:-

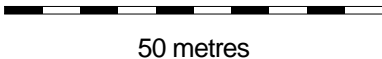
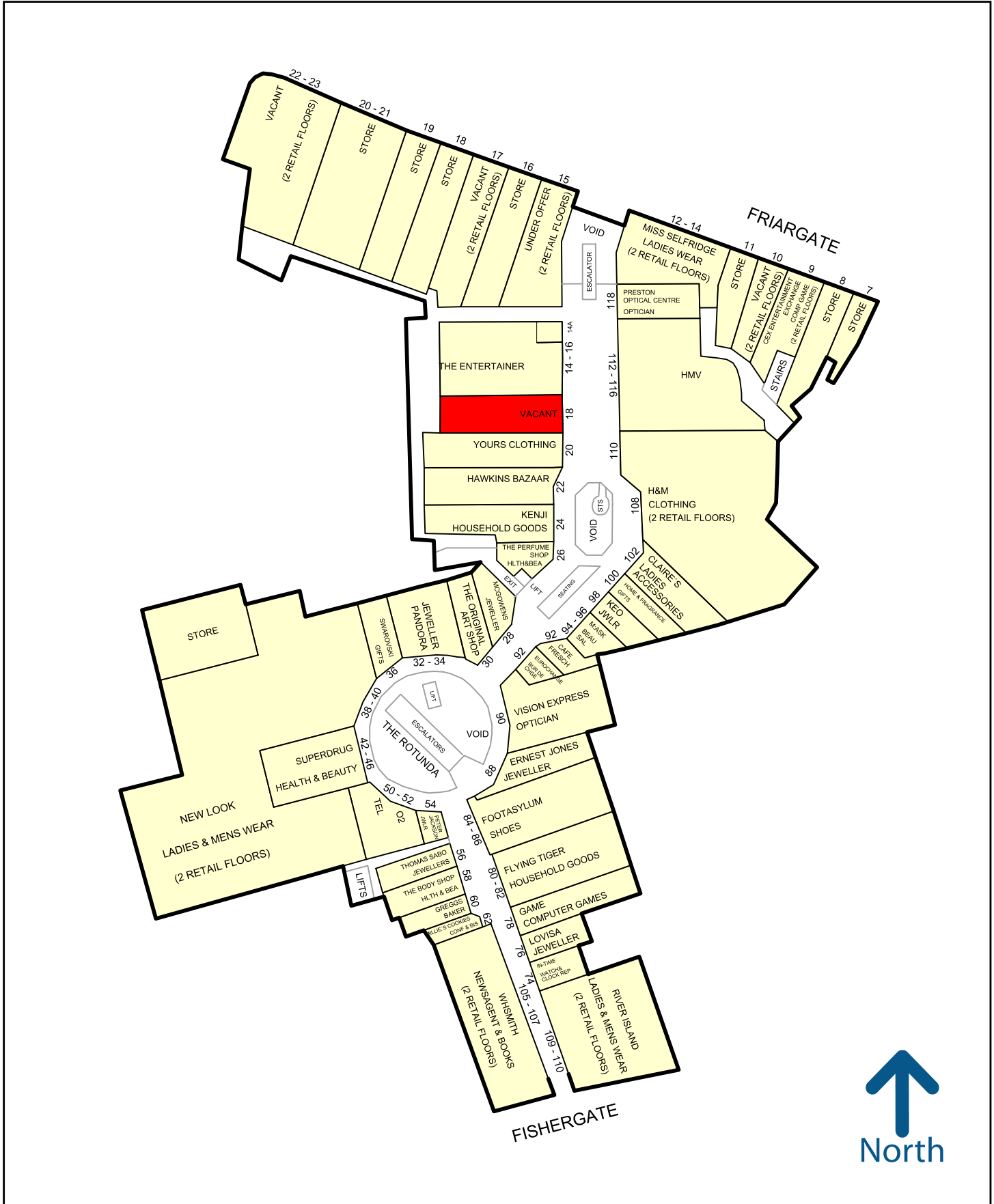
